**RESOLUTION ADOPTING THE PREVAILING WAGE RATES  
FOR LABORERS, WORKERS AND MECHANICS  
EMPLOYED BY THE BLOOMINGDALE PUBLIC LIBRARY**

**WHEREAS**, the State of Illinois had enacted “An ACT regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works,” approved June 26, 1941, as amended, being Chapter 820, Act 130, Sections 1-12, Illinois Compiled Statutes, 1996; and

**WHEREAS**, the aforesaid Act requires that the Bloomingdale Public Library investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Library employed in performing construction of public works for said Library.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Library Trustees of the Village of Bloomingdale, DuPage County, Illinois:

**Section 1:** To the extent and as required by “An ACT regulating wages of laborers mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works,” approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of this Library is hereby ascertained to be the same as the prevailing rate of wages for construction work in the DuPage County area as determined by the Department of Labor of the State of Illinois, as of September 2017, a copy of that determination being attached hereto as Exhibit “A” and incorporated herein by reference. The definition of any terms appearing in this Resolution which are also used in the aforesaid Act shall be the same as in said Act.

**Section 2:** Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of this Library to the extent required by the aforesaid Act.

**Section 3:** The Secretary shall publicly post or keep available for inspection by any interested party in the main office of this Library this determination of such prevailing rate of wage.

**Section 4:** The Secretary shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their name and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

**Section 5:** The Secretary shall promptly file a certified copy of this Resolution with both the Secretary of State and the Department of Labor of the State of Illinois.

**Section 6:** The secretary shall cause a notice to be posted on the Bloomingdale Public Library website, that lists the hyperlink to the prevailing wage schedule fr DuPage County. Said notice shall conform substantially to the notice attached hereto as Exhibit "B" and made a part hereof. Such publication shall constitute notice that this is the determination of the Bloomingdale Public Library and is effective.


